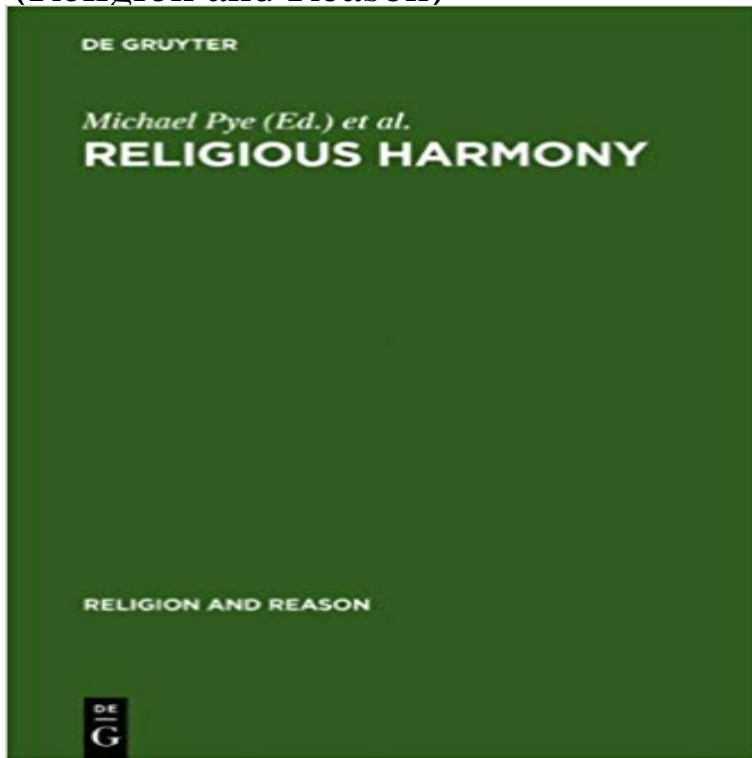


Religious Harmony: Problems, Practice, and Education. Proceedings of the Regional Conference of the International Association for the His (Religion and Reason)

Themes treated include the relation between theoretical approaches and religious viewpoints, practical problems and conflict resolution at the local level, and religious education with special reference to the role of Muslim schools (pesantren) in Indonesia.
