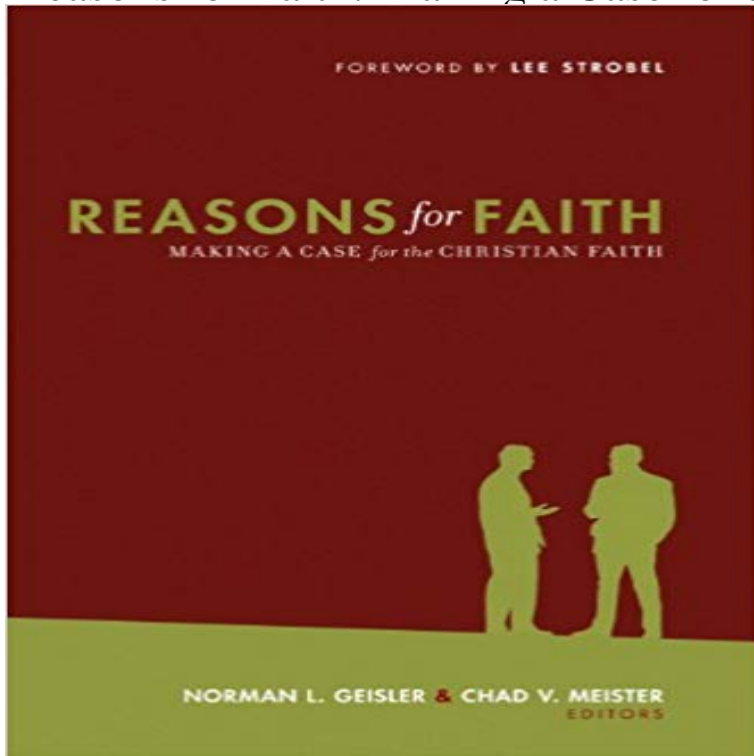


Reasons for Faith: Making a Case for the Christian Faith
