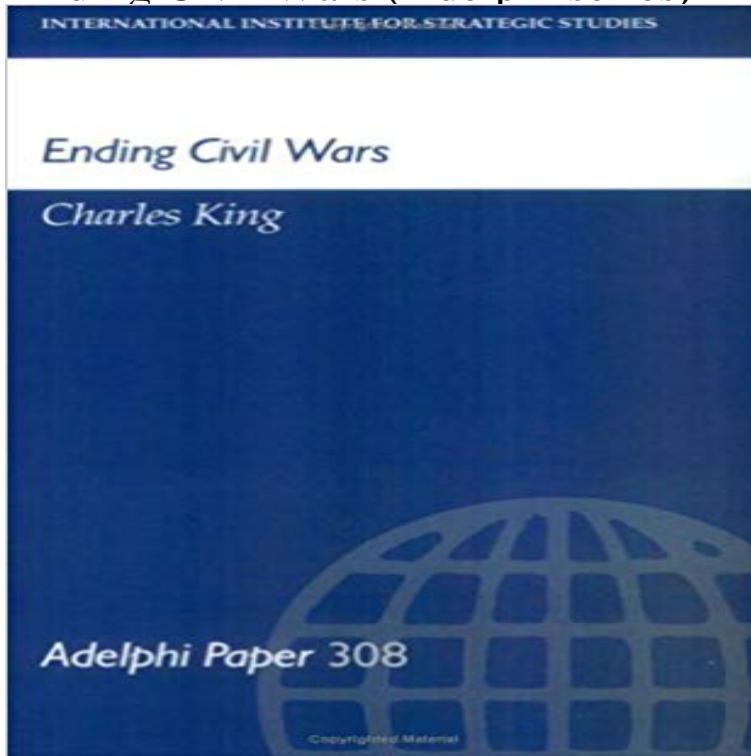


Ending Civil Wars (Adelphi series)
