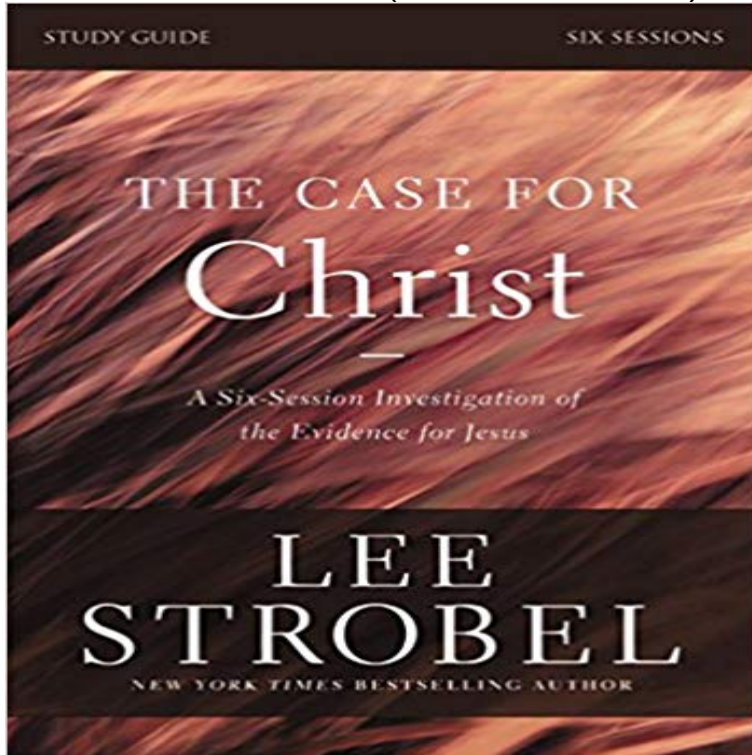


## The Case for Christ Study Guide Revised Edition: Investigating the Evidence for Jesus (The Case for...)
